- Revision to building to 'round off' eastern end and change slope of roof.
- Access area around building reduced to allow more room for planting.
- Hedgerow added where possible inside fencing.
- Adjustment of slope adjacent to turning area to reduce visual impact.
- Building colours product brochure attached with those colours used in the scheme identified.
- Red line includes swale extended to edge of attenuation pond.
- Fence on western boundary amended.
- Gutters removed on south and western facades due to risks of falling during maintenance. Water to be collected in French drain on edge of building perimeter path.
