I have been looking at this application today from a waste management perspective.

The drawing entitled Proposed Ground Floor Plan L02.20 shows two bin store areas. One for commercial waste and one for residential waste.

The residential waste shows that there will be bin chutes. We would like to strongly object to the use of bin chutes as they cause lots of issues as they often get blocked. They do not encourage recycling and the bin area does not look large enough to house the number of bins required?

I am unclear at this stage about the number of residential beds there will be. Please let the developer know that to take part in the domestic refuse and recycling collections the following calculation is used to work out the number of refuse and recycling bins required?

Refuse 60 litres per person per fortnight Recycling 60 litres per person per fortnight

The bin stores need to located at a point for easy access to the collection vehicles. Communal stores must be located no further than 25 metres from the nearest point of access for the collection vehicle.
