Thank you for sending the revised documents.

It is noted there will be wheelchair accessible accommodation in both the Co-Living and Hotel with a lift going to each of the floors.

- Will the lift be a full size passenger lift

Yes the lifts will be full passenger lifts. They will be enclosed lift cars within a built-for-purpose shaft.

- In the Co-Living will the Kitchen/Amenity area have some wheelchair accessible work surfaces

There will be accessible work surfaces in the communal areas.

- Will there be flexible storage space for anyone who may need to use a mobility scooter to get to the accommodation

There is currently allowances for large storage spaces on the ground, second, third and fifth floor levels.

The ground floor storage space is located close to the building entrances and the storage spaces on the upper floors are located close to the accessible rooms.
