Hi Alison,

With reference to the above Appeal, we have noticed an error in the annotation of the additional viewpoints contained in Appendix II to Mr Bunn's Proof of Evidence which indicates that they were taken with a lens of 50mm focal length. In actual fact they were slightly zoomed in at a focal length of approx. 75mm which is more representative of the view that would be achieved with the 'naked eye'. However, to provide a direct comparison with those taken the by Rule 6 Party, and in accordance with relevant guidance, please see attached revision to Mr Bunn's Appendix II which includes the same viewpoints as taken through a lens of both 75mm and 50mm focal length.

We will produce hard copies of each viewpoint at both focal lengths for the Inspector's benefit.
